About Abergavenny Community Centre

Abergavenny Community Centre opened in 2015 after residents persuaded the county council of the need for a multi-purpose space run for community benefit.

Abergavenny Community Trust was established in 2012 to manage the centre, and is now a charity. It receives no regular income from public sources or grant giving bodies. The Trust relies on donations and income from renting out rooms to meet the costs of keeping the centre open. We employ a small team of part-time workers on

modest wages, who are supported by volunteers. Whilst we are applying for grants to improve the building and build on what we do, we need more income to cover the day to day costs of keeping this valuable asset open.
